April 11, 2016

Acknowledgement of Guests: President Facinelli recognized Dory Kauffman who resides on East Arch Street. Mrs. Kauffman advised Council there are a number of hikers allowing their dogs to run loose in the Borough Park and on the railroad bed. She has been approached numerous times and fears she or her dog will be attacked. Council was asked to enforce a leash law in and around the Park.

Ordinance #351: Motion made by Jim Lodge, seconded by Dennis Henninger to enter into an Intergovernmental Cooperation Agreement with the Township of Jackson; Township of Reed, and Township of Wayne for the purpose of an Emergency Operations Plan. Motion carried.

<u>Bicentennial Hometown Heroes Banner Program:</u> Motion made by Dennis Henninger, seconded by Gary Shadle authorizing the Borough Maintenance Department to assist with the hanging of our Hometown Heroes Banners. Motion carried.

Yard and Craft Event: Motion made by Rodney Spicher, seconded by Mandy Carl to allow the Elizabethville Area Volunteer Association to host the annual Yard and Craft Day June 3, 2016 and June 4, 2016. And to authorize the Borough Maintenance Department to close Broad Street to traffic between Market and Church Streets and to post that area as a NO-PARKING zone. Motion carried.

<u>PEMA Resolution:</u> Motion made by Dennis Henninger, seconded by Mandy Carl to appoint the Borough Secretary as the Designated Agent authorized to execute all forms and documents for the purpose of obtaining financial assistance under the Emergency Assistance Act. (January 2016 snowstorm) Motion carried.

<u>Memorial Day Parade:</u> Motion made by Mandy Carl, seconded by James Lodge to allow the Elizabethville American Legion, Post 404 to host the annual Memorial Day Parade on May 30, 2016. Motion carried.

<u>Lehman's Inc. Invoice:</u> Motion made by Mandy Carl, seconded by Fred Renn to pay an invoice out of the County Grant Funds(2015-04) for Upper Dauphin Recreation Association (UDRA) of \$3252.24 to Lehman's Inc. Motion carried.
