# ELIZABETHVILLE BOROUGH COUNCIL MEETING MINUTES

## July 12, 2016

The Elizabethville Borough Council met on July 12, 2016 in the Municipal Building at 68 S. Moore Street in Elizabethville, Pennsylvania. President James Facinelli called the meeting to order at 7:00pm. The meeting opened with the Pledge of Allegiance.

<u>Approval of Minutes</u>: Motion made by Mandy Carl, seconded by Dennis Henninger to approve the meeting minutes of June 13, 2016 as presented. Motion carried.

President Facinelli recognized Mike Miller. The Bicentennial Committee is requesting the use of the entire park from <u>August 12, 2017 thru August 19, 2017</u>. Nightly concerts, a Community Day, Fire/Rescue demonstration, pool day, street carnival, several parades including the Grand Celebration Parade and a Lee Greenwood Concert have been planned for the week. The Bicentennial Committee is looking for approval to use the Legion Baseball Field for the Lee Greenwood Concert and close the roads surrounding the park.

President Facinelli next recognized Patty Donnel who reported things are going well at the community pool. Several fund raising events have been planned.

Streets & Maintenance – Monthly report distributed to council members. The Berrysburg Mayor contacted Matt Schaffner to inquire if he would be interested in painting their cross walks and installing street signs.

<u>Contract with Berrysburg Borough:</u> Motion made by Dennis Henninger, seconded by Gary Shadle authorizing Matt Schaffner/Elizabethville Borough Council to contract with Berrysburg Borough for installing street signs and painting cross walks. The work schedule should be approved with the Streets Committee Chairman. Motion carried.

Codes Enforcement Officer - Monthly report on file.

Building, Lighting & Grounds - Nothing to report at this time.

Water, Refuse & Sewage – Nothing to report at this time.

Budget & Finance – D. Henninger advised council they received the 6 month year to date Income and Expense report. Overall the budget looks good; most line items are within budget.

Park & Recreation – M. Carl suggested the large playground equipment be painted to match the newer equipment. Maintenance will put it on the scheduled. Council discussed replacing the 'Welcome to Elizabethville Signs'. Two quotes were presented each company quoted a different sign material. M. Carl will research the subject and present three quotes at a later date.

Personnel – R. Spicher reported he is still trying to schedule time to meet with the employees for their Performance Reviews.

IT – M. Carl reported that last month's request from the Elizabethville Area Authority was posted to the Borough's website.
